be seeking anything additional. Commissioner McGrain also requested that when they do approach the Board, that a presentation is made regarding their plans.

Commissioner Bahar-Cook stated that the Land Bank has agreed to allow CBRE to market the property on 496 and Washington (the old Deluxe Inn site) nationwide to receive proposals for what is possible on that spot for suitable commercial properties.

#### Other issues:

Clerk Barb Byrum informed the Caucus that there were problems with audio recording the last Democratic Caucus meeting and video/audio recording the last Board of Commissioners meeting on February 25, 2014 due to firewall issues. She also stated that there is a concern with the firewall issues having an impact on allowing Municipal Clerks to communicate election results for the upcoming May Election. Clerk Byrum said her office is communicating with MIS to solve the problem.

Commissioner McGrain asked Clerk Byrum how often the online roster of who has filed to run for election will be updated on the County's website.

Clerk Byrum stated that the roster was most recently updated on Friday (March 7) afternoon and that it will not be updated daily, but rather updated regularly on Friday afternoons until closer to the filing deadline.

Commissioner Nolan asked who the Elections Coordinator is.

Clerk Byrum stated that Angela Wittrock was the Elections Coordinator, but that she is no longer an employee.

Commissioner Bahar-Cook stated that she has been selected to serve as the Rotary Chair for the month of November and she will be asking those from Ingham Academy to serve as guest speaker for one of the meetings that month.
