#### LIMITED PUBLIC COMMENT

Tom Vali commented on the large number of invasive species sites at Lake Lansing North and how these invasive species are overrunning Lake Lansing North and that if they are not controlled they are harmful to plants and insects/wildlife. Jim Hewitt is in support of a stewardship management plan. Mr. Hewitt stated that Lake Lansing North's biodiversity is quite rich which includes over 775 species of plants found including endangered plant species which is threatened by the invasive species which is why a stewardship program is so important.

#### **CONSIDERATION OF CONSENT AGENDA**

Ms.Hamrick moved to adopt a consent agenda consisting of all actions items, with the exception of Agenda Items A, B and D. Ms. Thomas supported the motion.

Those agenda items that were on the consent agenda were approved by unanimous roll call vote.

#### **DISCUSSION ITEMS**

#### **Boathouse** proposal

Mr. Emens went over the proposal. Ms. Pawar stated that she is concerned that the sailing club will possibly be too expensive for the underserved, but advised the park staff to get more information from the MSU Sailing Club and to possibly sell our boats, especially our swan boats to them. Mr. Morgan stated that the swan boats will go to Hawk Island and Burchfield Park. Mr. Morgan also stated that park staff will approach Michigan State University sailing club as requested and that the park does not want obstacles for anyone. Mr. Morgan stated that the park also does not want to duplicate services within our own parks. Ms. Pawar would also like for the parks department to put something out on social media and the website explaining to the community what the parks will be doing so that they are aware of the changes taking place. Commissioner Stivers would also like to see a letter sent to Meridian Township stating the changes as well.

#### E-bikes

Mr. Morgan stated that the DNR is currently working on rules and regulations in regards e-bikes and that their stance will be centered on accessibility. Mr. Morgan stated that the parks department worked with county attorneys when writing the park rules and the parks department is presently allowing class I & II e-bikes on the trails. Mr. Morgan also stated to date there have been no issues.

#### Action Plan

Mr. Morgan stated that the parks department simplified the action plan and is focusing on the next 5 years and that anything beyond will be tagged as long term goals, however those goals may be moved up if a grant is received. Mr. Emens stated that he is working on an RFP for a stewardship program. Mr. Emens plans to have an RFP for the development stage and then another RFP for the following 5 years for the work. Mr. Emens also stated that there used to be a large number of volunteers involved that were geared towards stewardship which kept the invasive species for taking over, however they have moved on. Mr. Morgan stated that our management team manages the formal areas, however we need a plan for the large amount of natural, native land in our parks. Mr. Pratt advised that we look into Cisma, that they may be able to provide us with help.

# RESOLUTION TO AUTHORIZE A CONTRACT WITH LAUX CONSTRUCTION FOR IMPROVEMENTS TO LAKE LANSING PARK SOUTH

WHEREAS, the Purchasing Department solicited proposals from qualified and experienced contractors

for the purpose of entering into a contract for making improvements to Lake Lansing Park South; and

WHEREAS, this general scope of work includes, but is not limited to a new restroom and concession building, demolition of a restroom building, HMA parking spaces, concrete sidewalk removal and replacement, site furnishings, sanitary sewer, water and electrical service, signage, and restoration; and

WHEREAS, there is \$1,549,409 available in line item 228-62800-967000-TR061 and \$81,230 available in line item 228-62800-967000-TR082 previously authorized by Resolutions #19-093, 19-047 and 20-028, \$3,000 from the Special Assessment District (SAD) - Meridian Township, \$1,000 from Lake Lansing Property Owner Association (LLPOA), \$7,185 available in line item 228-75999-974000-9P13, and \$140,000 available in line item 228-62800-967000-TR084 for the project; and

WHEREAS, the Ingham County Parks, as part of the Lake Lansing Park South improvement project, is requesting additional funding from the Trails and Parks Millage fund balance in the amount of \$799,269 to complete this project; and

WHEREAS, after careful review and evaluation of the proposals received, the Evaluation Committee recommends that a contract be awarded to Laux Construction.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners hereby approves entering into a contract with Laux Construction for the base bid of \$2,512,105.98, including Post-Bid Addendum #1 Bid Additive 1 in the amount of \$31,000, Post-Bid Addendum #1 Bid Additive 2 in the amount of \$26,000, the substitute to deduct \$55,000 for cupolas, plus a contingency of \$62,853 (2.5%) to cover any unforeseen circumstances totaling a total contract amount not to exceed \$2,576,958.98 for improvements to Lake Lansing Park South.

BE IT FURTHER RESOLVED, that the Controller/Administrator is authorized to transfer \$7,185 from 228-75999-974000-9P13 to 228-62800-967000-TR061.

# RESOLUTION TO MODIFY A CONTRACT WITH PENCHURA RECREATION PRODUCTS AND SERVICES FOR REPLACEMENTS OF A PORTION OF THE LAKE LANSING SOUTH COUNTY PARK PLAYGROUND TO COMPLY WITH THE INGHAM COUNTY PREVAILING WAGE POLICY

WHEREAS, Resolution #22-394 authorized a contract with Penchura Recreational Products and Services in the amount of \$87,535 with a contingency not to exceed \$5,000; and

WHEREAS, during preparation of the contract, it was discovered that the General Services Administration, GSA Contract utilized for purchasing and installation of the playground, did not meet the requirements of the Ingham County Prevailing wage policy #02-263; and

WHEREAS, to comply with the Ingham County Prevailing wage policy, an additional amount of \$5,952 is needed for a total amount of \$93,487, with a contingency of \$5,000.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners hereby approves entering into a contract with Penchura Recreational Products and Services (General Services Administration, GSA) for replacement of a portion of the playground at Lake Lansing South County Park, which included Prevailing Wage, in the amount of \$93,487 with a contingency not to exceed \$5,000.

BE IT FURTHER RESOLVED, that there are funds available in line item 208-75200-974000 for the project.

BE IT FURTHER RESOLVED, that the Chairperson of the Board of Commissioners is hereby authorized to sign any necessary contract documents on behalf of the County after approval as to form by the County Attorney.



Dear Nicole,

I am delighted to inform you that your project, the Holt-Mason Trail Connection, was funded at \$2.75 million in the Fiscal Year 2023 budget, which is set to be signed into law shortly. This was the full amount you requested from our office in April of 2022.

First, congratulations! You've done great work getting us to this point. I want to thank you for your hard work during what was a very tight application timeline and your patience during what has been a long and sometimes frustrating process. Our office received over 90 applications for Community Project Funding, and it is a testament to you and your team's work that your project was selected. The community and our District will directly benefit from your effort – so thank you. You should feel proud, and feel free to tell your community as you see fit.

In terms of **next steps**, I would again ask for your patience: In the coming months, the federal agency relevant to your project will reach out to you directly with guidance on how and when you will receive the funding. This will likely involve a perfunctory application to the respective agency. This process will be largely administrative, as the funds have already been set aside for your specific project – but you will need to do their required paperwork to get the funds moving. And to manage your expectations, community projects I got funded last year waited between 6-12 months to get their funds in hand.

Of course, my office will be here to help every step of the way – from first engagements with federal departments and agencies, to ground breakings and ribbon cuttings. We will continue to pass along any guidance we receive related to your project. If you have any questions during this process, please reach out to Austin Girelli, cc'd here.
